RESOLUTION NO. 12-108R

OF RESOLUTION OF THE BOARD COUNTY OSCEOLA COUNTY, FLORIDA COMMISSIONERS OF APPROVING THE BUDGET FOR FISCAL YEAR 2012-2013; DIRECTING THE COUNTY MANAGER TO DELIVER A LETTER OF NOTIFICATION TO THE SHERIFF; PROVIDING FOR CONFLICTS AND SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, on September 5, 2012, the Board of County Commissioners of Osceola County, Florida (the "Board") adopted Resolution No. 12-091R, approving the tentative budget for Fiscal Year 2012-2013; and

WHEREAS, upon approval of the tentative budget for Fiscal Year 2012-2013, the Board prepared and advertised a statement summarizing all of the adopted tentative budgets, as required by Section 129.03, Florida Statutes; and

WHEREAS, the Board has conducted a public hearing to consider adoption of its final budget for Fiscal Year 2012-2013 and the millage rates necessary to fund the final budget, as required by Sections 129.03(3)(c) and 200.065, Florida Statutes; and

WHEREAS, the Board has adopted Resolution Nos. 12-106R, and 12-107R, adopting the final millage rates for Fiscal Year 2012-2013;

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF OSCEOLA COUNTY, FLORIDA:

SECTION 1. ADOPTION OF FINAL BUDGET

- (A) The final Osceola County budget for Fiscal Year 2012-2013, totaling \$844,594,832, as summarized by fund and revenue/expense category in Schedule A, is hereby approved and adopted. There are hereby appropriated out of anticipated revenues and balances brought forward, all funds and monies necessary to meet the appropriations and reserves stipulated by and in said budget
- (B) It is hereby found and determined that each of the expenditures authorized by the budget for Fiscal Year 2012-2013, as summarized in Schedule A, is required to fund programs and facilities necessary for essential public purposes affecting the health, welfare and safety of the inhabitants of Osceola County or which are legally mandated by applicable law.
- **SECTION 2. LETTER OF NOTIFICATION.** The County Manager is hereby authorized and directed to prepare, execute and deliver a letter of notification informing the Sheriff of budget changes subsequent to his request and stating the Sheriff's budget for Fiscal Year 2012-2013.

CONFLICTS AND SEVERABILITY. All sections or parts of SECTION 3. sections of all resolutions or parts of resolutions in conflict herewith are hereby repealed to the extent of such conflict. If any section, subsection, sentence, clause or provisions of this Resolution is held unconstitutional, inoperative, or void by a court of competent jurisdiction, such holding shall not affect the remainder of the Resolution.

EFFECTIVE DATE. This Resolution shall take effect immediately **SECTION 4.** upon its adoption.
