Osceola County invites you to a public information meeting regarding the Boggy Creek Road Widening Project on Thursday, December 2, 2021. The purpose of the project is to address capacity and safety needs along Boggy Creek Road from Simpson Road (C.R. 530) to Narcoossee Road.

Osceola County is designing the preferred alternative that was selected earlier this year by the Osceola County Board of County Commissioners, which will provide two 11-foot travel lanes in each direction separated by a raised median. Traffic signal modifications, drainage improvements, and construction of an 8-to-10-foot-wide multi-use path with a 4-to-7-foot-wide buffer on the south side of the roadway are included. The design also includes a 6-foot-wide sidewalk with a 4-to-7-foot-wide buffer on the north side of the roadway. The public meeting is an opportunity for the community to learn about the design, ask questions and provide input. The project is currently in the design phase. Construction is expected to begin in fall 2023.
